NOTICE TO TRADE

Export Container Detention Adjustment

Dear Valued Customers,

Please note that effective from 1st July 2016, our Export Container Detention tariff will be adjusted to the following.

PIL grant 14 days' free export detention on all export containers. These 14 free calendar days are calculated from the date the empty container is picked up from the depot, until the date the container is returned back full to the terminal for export.

20 GP	AUD \$50.00/day	From 15 th day onwards
20 OT - 20' Open Top	AUD \$60.00/day	From 15 th day onwards
20 FR - 20' Flat Rack	AUD \$60.00/day	From 15 th day onwards
20RH	AUD\$95.00/day	From 15 th day onwards
40 GP / HC	AUD \$100.00/day	From 15 th day onwards
40 OT - 40' Open Top	AUD \$120.00/day	From 15 th day onwards
40 FR - 40' Flat Rack	AUD \$120.00/day	From 15 th day onwards
40 RH	AUD \$180.00/day	From 15 th day onwards

N.B. Containers not shipped and returned to the depot will be subject to LOLO charges and export detention will be charged from day of empty pick up until the day of empty return (with no free time).
